Application Guide to
Soshi Internship for the 2025 Academic Year

1. Objectives

The Soshi Internship of the Japanese Language Department at TIBC is offered to international students who want to study Japanese language, and want an internship opportunity in a Japanese educational group for their own career advancement. Applicants must submit application documents, including a letter of recommendation (see '2. Eligibility').

2. Eligibility

Applicants must:

- (1) Read the application guide carefully, fill in the application documents supplied by TIBC, and submit all required documents to TIBC (see '17. Contact us');
- (2) Include as part of the application documents a letter of recommendation prepared by the school where the applicant studied Japanese or by a teaching staff member of the school;
- (3) Be able to study and an internship in Japan as of April 2025;
- (4) Be able to obtain a student visa in Japan;
- (5) Comply with the rules and regulations set by TIBC.
- (6) Be physically and mentally fit to study abroad.

3. Qualification to be conferred

Successful applicants will study at the Japanese Language Department at TIBC for one year. Once they successfully graduate, a certification of completion will be conferred.

4. Program fees

An exemption of the tuition fee for a person who has an Experience and qualifications as an English teacher for 6 months (300,000 Japanese yen) and an exemption of the tuition fee for a person who has an Experience and qualifications as an English teacher for one year (600,000 Japanese yen) cover all of the tuition fee. An exemption of the tuition fee for others for 6 months (225,000 Japanese yen) and an exemption of the tuition fee for others for 1 year (450,000) cover 3/4 of the tuition fee. The fees payable by students are as follows (unit: Japanese yen):

5. Internship period

1 April 2025 – 30 September 2025 (6 months) /31 March 2026 (one year)

6. To apply

Applicants must fill in application forms (downloadable from the designated URL) and send all required documents to Mr. Uemura for TIBC by email (see '17. Contact us').

7. Application documents

- (1) Your CV with an ID photo attached (downloadable from our website and SNS page)
- (2) A letter of recommendation prepared by the school where you studied Japanese or a teaching staff member of the school

8. Application period

1 September 2024 – 12:00 noon, 30 September 2024 (Japan Standard Time)

Incomplete or late applications will not be accepted. Submitted documents will not be returned.

9. Application process

Applicants will be screened and selected to attend interviews. Interviews will take place in September 2024. Successful applicants prepare visa applications from October.

10. Obligations of an intern

Once successfully selected as an intern, you must:

- (1) Submit documents required for admission to TIBC immediately and apply for a student visa;
- (2) Register to study at the Department of Japanese Language at TIBC from April 2024;
- (3) Go to the internship school every weekday and engage in the internship. Accepting schools will be determined by TIBC based on student aptitude. The internship destination will be one of Clark Memorial High School campus in Kanto area.
- (4) Prepare for classes, give lectures, and perform other school tasks while doing internship in a school;
- (5) Stay at TIBC's student accommodation and cooperate with the operation of the dormitory during the enrolment period.

11. The Department of the Japanese Language of TIBC

Students at the Japanese Language Department must be enrolled in either morning classes or afternoon classes. Students will be classified by the placement test upon arrival and will not be able to choose between morning and afternoon classes.

Morning classes: 08:45 – 12:10 Afternoon classes: 13:00 – 16:25

* There are 218 days of classes per academic year. The total hours of study per year are 872 hours.

12. Termination of the program

Programs will be terminated and the difference between the scholarship fee and the full tuition fee (see'4. Program fees) must be paid if recipients commit one of the following points:

- (1) Attendance of 90% or less of obligatory classes;
- (2) Failure to perform the obligations required of interns (see '10. Obligations of an intern');
- (3) Failure to comply with the rules and regulations set by TIBC;
- (4) Misstatement in the application documents, including the letter of recommendation;
- (5) Failure to satisfy any requirements mentioned in this application guide; or
- (6) Found unsuitable by TIBC to continue internship.

14. Miscellaneous

- (1) If interns complete their studies and wish to continue studying for another year, the second-year fees (695,000 Japanese yen) will be payable for their continued study.
- (2) If interns do not intend to continue studying after their internship period, they must depart from Japan by 15 October 2025 (six months students) / 15 April 2026 (one year students) regardless of the date of expiration stated on their residence cards.
- (3) If interns decide to withdraw from the program before its completion for personal reasons, they must depart from Japan immediately and will not receive any refunds.
- (4) If interns should fall into any of the provisions of the Clause 12 and lose their internship rights, they must depart from Japan immediately.
- (5) TIBC have no responsibility for the delay by the Immigration Bureau of Japan in issuing Certificates of Eligibility (COE). There will be no reduction of cost associated with the delay.

15. Personally identifiable information

The personal information of applicants will not be used for other purposes than the educational activities of TIBC.
